In order to seek the most appropriate benefits from the Company's Premier Place Building's asset that needs a process with an in-depth study and time-consuming, the Company and PFC have agreed to extend the date of registration of the ownership transfer of the agreed-upon property at the Bangkok Metropolitan Land Office to within 19 November 2025.
